The Centers serves people living with mental illness or addiction through a comprehensive approach that includes case management, counseling, psychiatric services, primary care, convenient access to prescription medication, medication compliance/management, substance abuse services, and comprehensive wellness ranging from nutrition and fitness to art therapy and parenting support.

The Centers serves families with high quality preschool and childcare services through its 2,000 Days early learning centers and in-home services. The 2,000 Days program features a strong academic component to prepare children for school and life, but also the childcare coverage that working families need to remain employed.

The Centers' ease@work program collaborates with leadership teams to strengthen an organization's performance by strengthening employee performance. The Centers operates 16 locations across Greater Cleveland and employs a staff of nearly 600 skilled professionals, many of whom are thought-leaders in their area of expertise.
